

Copyright Policy

The Mylifescene.com Web Site and Facebook Application (referenced collectively as "Mylifescene.com") are owned and operated by Talent DNA LLC. Talent DNA LLC takes copyright infringement seriously. Portions of material on Mylifescene.com are user-submitted. Therefore, as a condition of use, users are asked to agree to our [Terms of Use](#) which states that copyrighted material must not be submitted without permission from the copyright holder. Even with this precaution, it is still possible that copyrighted material has been published on Mylifescene.com.

My Life Scene Talent DNA Profile is Patent Pending (Official Filing Receipt United States Patent and Trademark Office was filed on April 6, 2017, and has been assigned Application No. 62/482,405)

It is Talent DNA LLC's policy to respond expeditiously to notices of claimed copyright infringement that comply with the Digital Millennium Copyright Act and other applicable intellectual property laws. In order to comply with the DMCA, Talent DNA LLC may remove material claimed to be infringing. In such cases, Talent DNA LLC will attempt to contact the user who submitted the material in order to inform them of the removal and inform them of their option to make a counter notification pursuant to the DMCA.

Knowing When and When Not to Submit Notifications

If you are unsure whether you should submit a DMCA notification or counter notification (such as if you are unsure if certain material is or is not infringing on another party's copyright), or if you are not sure how to do so properly under the DMCA, we recommend that you consult an attorney.

Be aware that you may be held liable for damages including costs and attorneys' fees if you materially misrepresent that your copyrights are being infringed by another party or if you submit a counter notification that materially misrepresents that you are not infringing the copyrights of another party.

We may post your notification or counter notification with personal information removed to an applicable website.

Submitting a Notification of Claimed Infringement

If you are a copyright holder or authorized agent of a copyright holder who believes an infringement has occurred on Mylifescene.com, you may send a DMCA-compliant notice of claimed infringement in written form to Talent DNA LLC's designated agent. Include the following information as outlined in the DMCA (512(c)(3)(A)(i-vi)).

(i) A physical or electronic signature of a person authorized to act on behalf of the owner of an exclusive right that is allegedly infringed.

(ii) Identification of the copyrighted work claimed to have been infringed, or, if multiple copyrighted works at Mylifescene.com are covered by a single notification, a representative list of such works at Mylifescene.com.

(iii) Identification of the material that is claimed to be infringing or to be the subject of infringing activity and that is to be removed or access to which is to be disabled, and information reasonably sufficient to permit Talent DNA LLC to locate the material (provide URL(s)).

(iv) Information reasonably sufficient to permit Talent DNA LLC to contact you. An e-mail address is preferred.

(v) A statement that the complaining party has a good faith belief that use of the material in the manner complained of is not authorized by the copyright owner, its agent, or the law.

(vi) A statement that the information in the notification is accurate, and under penalty of perjury, that the complaining party is authorized to act on behalf of the owner of an exclusive right that is allegedly infringed.

Upon receiving your notification, Talent DNA LLC will remove the material from Mylifescene.com that is claimed to be infringing. We will notify the person who submitted the material and inform them of their option to submit a counter notification if they believe your claim is incorrect.

Submitting a Counter Notification

Alleged infringers may send a DMCA compliant counter notification in written form to Talent DNA LLC's designated agent containing the following information (512(g)(3)(A-D)).

(A) A physical or electronic signature of the alleged infringer.

(B) Identification of the material that has been removed or to which access has been disabled and the location before removal (provide URL(s)).

(C) A statement under penalty of perjury that the alleged infringer has a good faith belief that the material was removed or disabled as a result of mistake or misidentification of the material to be removed or disabled.

(D) Your name, address, telephone number, e-mail address, and a statement that you consent to the jurisdiction of Federal District Court for the judicial district in which your address is located, or Tarrant County, Texas if your address is outside of the United States, and that you will accept service of process from the person who provided notification under subsection (c)(1)(C) or an agent of such person.

When Talent DNA LLC receives a counter notification it will be shared with the party that filed the initial notification of claimed infringement. Under the DMCA, the material in question may be placed back online no earlier than 10 days and no later than 14 days from the date that the counter notification is received, unless Talent DNA LLC receives notice that the party that filed the initial notification of claimed infringement is seeking to obtain a court order restraining the restoration of removed material.

Termination of Repeat Infringers

Talent DNA LLC will take appropriate measures to terminate, ban and/or restrict the access of repeat infringers to Mylifescene.com.
